What is CHRP?

Established in 1983
Longest running program of its kind
Statewide research program
Collective investment:

~\$36oM in research

~2000 projects funded

Institution Type	Funded projects	\$ Invested
UC Campuses	1450	\$257M
Non-UC Academic	148	\$30M
Non-profit/NGO	161	\$35M
Clinic/Med Research	183	\$26M
Government	37	\$9M

Basic Biomedical and Translational Science Discovery: Early-Stage Investigator (ESI) Pilot Awards

Requirements

Eligibility

- Early-stage investigator with mentor
- Holds/will have PI status (post-docs ok)
- Minimum 10% effort for PI
- Conduct research in CA only

Goals/Objectives

- Fund 5-9 highly innovative pilot studies by ESI
- Limited applicant pool (n=20 max via competitive LOIs)

Expectations

- HIV-specific research question, basic bio and/or transl.
- Likely to yield prelim data to apply for larger awards

Review Criteria

Letters of Intent

- Innovation (50%)
- Significance and Impact (25%)
- Approach and Feasibility (25%)

Full Application

- Innovation (30%)
- Significance (20%)
- Approach and Feasibility (50%)

Budget

- Direct costs up to \$200,000/2 years
- Indirect costs per policy as stated in Grants Administration Manual (max 35%)





Innovative Approaches to HIV Prevention and Care: Social and Behavioral Research Open Call

Requirements

Goals/Objectives: Interventions will improve access/uptake of prevention and/or care.

Expectations: Projects grounded in Social/Behavioral frameworks will address a significant aspect of the CA HIV epidemic through innovative approaches

Eligibility

- Path 1: All Investigators
- Path 2 Career Development (Mentored ESI)
- Holds or will have PI status
- 10% effort
- Conduct research in CA only

Review Criteria

LOI

- Innovation (50%)
- Significance and Impact (25%)
- Approach and Feasibility (25%)

Full Application

- Innovation (20%)
- Significance (20%)
- Approach and Feasibility (50%)
- Investigator Impact (10%)

Budget

- Direct costs up to \$250,000/2 years
- Indirect costs per policy as stated in Grants Administration Manual





Review & Scoring

Three Level Review Process at Each Stage					
Review Level	LOI Stage	Full Application			
1 – Compliance	RGPO staff	RGPO staff			
2 – Merit	CHRP + Advisory Council	Independent Reviewers			
3 – Programmatic	CHRP + AC	Advisory Council			

Score	Descriptor	Strengths/Weaknesses
1	Exceptional	Extremely strong with essentially no weaknesses
2	Outstanding	Extremely strong with negligible weaknesses
3	Excellent	Very strong with only some minor weaknesses
4	Very Good	Strong but with numerous minor weaknesses
5	Good	Strong with at least one moderate weakness
6	Satisfactory	Some strengths but also some moderate weaknesses
7	Fair	Some strengths but with at least one major weakness
8	Marginal	Some strengths but with at least one major weakness
9	Poor	Some strengths but with at least one major weakness

Grant writing tips and common questions





Pearls for Grant writing

- The most important thing in grantwriting is....
- The most important section of your full application is...
 - CHRP requires two abstracts: tailor each one
- Proofreading: a "cold read" will benefit your reviewers
 - "One Voice" if you have multiple writers
- Research Plan
 - No required sections (background, methods, etc.)
 - Funnel method: introduction should set up the info to come
 - Be explicit: enrollment criteria; sample size; outcome measures





Applicant Questions from Prior Years

- What topics is CHRP hoping to fund? What does CHRP really want?
- Is my topic ok?
- Am I an early-stage investigator?
- Can post-docs apply?
- Can I apply if I currently have a CHRP grant?
- Can two of us apply as co-Principal Investigators?
- Can I include a community investigator?
- What budget info do I need to include at the LOI stage?
- Is there a salary cap?
- Can I include tuition for a student who is living in California while matriculating at an institution outside California?







Applicant Questions Received This Year to Date

- 1. Is my topic suitable for this RFP? => Don't discuss here; call your PO
- 2. For social/behavioral
 - Will the ESI vs non-ESI paths be assessed separately?
 - If I will get my terminal degree at the start of the award period, should I apply as ESI or as non-ESI?
- 3. Eligibility:
 - Can I hold this and another ESI award at the same time?
 - Can I retain this award if I apply as a post-doc but get promoted to scientist?
 - ...if I don't get promoted and remain a post-doc?
- 4. Budget
 - Is the salary support in this award meant to cover near 100% of ESI salary support?
 - Is there a cap on salary support?
 - Will study drug be available at no cost?
- 5. Other
 - Where are the Research Priority/Subject/Focus areas listed?
 - Do character limits include spaces?
